





Agreement of Co-operation

Agreement between Institution of Civil Engineers

And

The Polish Chamber of Civil Engineers - Polska Izba Inżynierów Budownictwa (PIIB)

And

The Polish Society of Civil Engineers and Technicians - Polski Związek Inżynierów i Techników Budownictwa (PZITB)

Preamble

The Institution of Civil Engineers and the Polish Chamber of Civil Engineers and the Polish Society of Civil
Engineers and Technicians have entered into this Agreement to promote the development of a closer
working relationship, to the mutual benefit of their members and in the interests of the engineering
profession.

Reciprocal Arrangements

- The following facilities will be made available to members of each institution who are temporarily resident in the other country.
 - a Attendance at all meetings of the host institution (other than Annual and Special General meetings which are concerned with institution business).
 - b Use of the host institution's buildings including, for example, the Library (for reference purposes only), and catering and other facilities, where these are available, in line with conditions applicable to members of the host Institution.
 - c Participation in the activities of any regional branches in the host country.
 - d Publications and periodicals at members discounted rate where possible.
 - e For members temporarily resident in a third country, participation in activities of a Local Association, Branch or Group of the other institution there if one exists.

The facilities are normally granted for one year but may be extended on request.

- Attendance at meetings arranged by the other institution will be on the same conditions that are applicable to the members of the host institution (i.e. subject only to any special local charge that may be levied for that meeting).
- 4. The Institution and the Polish Chamber of Civil Engineers and the Polish Society of Civil Engineers and Technicians will continue to exchange appropriate publications.

- Joint sponsoring of seminars, conferences and meetings of mutual interest will be encouraged. Each institution will facilitate the holding of local meetings by the other, and will encourage its own members to attend such meetings.
- 6. ICE, PIIB and PZITB will work together as required to facilitate the mutual recognition of professional qualifications in accordance with relevant EU legislation.

Review, Amendment and Termination

7. This Agreement shall run for three years. Thereafter it will be renewed automatically for a further three years if not terminated by either institution. Amendments to the Agreement may be proposed at any time but will not be valid until they have received approval from the Councils of both institutions. The Agreement may be terminated by either institution on giving six months notice in writing.

Ratification

8. The Agreement shall not be binding until it has been formally approved by the Councils of both the Institution, the Polish Chamber of Civil Engineers and the Polish Society of Civil Engineers and Technicians
